Your privacy:

The following Privacy Policy sets out the personal data that we collect about you as a customer, stakeholder, or other interested party and refers to our commitment to treat this information with the utmost care and confidentiality. Your data will never be used to sell, rent or trade with other email lists for marketing purposes; we are committed to maintaining the trust and confidence of visitors to our website, our customers, partners and suppliers.

Collection and use of personal information:

- Protected against any unauthorised or illegal access by internal or external parties.

- Communicated informally.
- Stored for more than a specified amount of time to comply with our service commitments to you and to enable us to provide you with ongoing products and services as agreed, and to process payments associated with this.
- Accessed by any other companies, as direct links will not be used on our website.

Data storage:

We will always ensure that your information is treated securely and adequately protected in accordance with this Privacy Policy. Although transmission of information via the internet is not completely secure, once we receive your information, we use strict procedures and security features to assist in preventing unauthorised access.

Any third party working on behalf of Lindsay Beckman & Co Ltd, who may have access to information which you give to us, is required to keep that information secure and confidential and to use it for no other purpose than to carry out the services they are performing for Lindsay Beckman & Co Ltd.
